Terms & Conditions

Term	Description
Definition of Qarz-e-Hasana Loan	A goodly loan of funds made by the Lender to Barnoldswick Learning & Cultural Trust (BLCT) that is unsecured, interest-free, and to be repaid as and when BLCT is able to repay the loan, taking into account the requirements by the Lender(s) in this Agreement and associated terms and conditions.
Proof of Identity and Address	BLCT will not accept Qarz-e-Hasana without appropriate proof of identity and address.
Unrestricted Loan	BLCT only accepts Qarz-e-Hasana on the basis that it is unrestricted, i.e. it can be used by BLCT as it deems appropriate.
Extension of Agreement	When the agreement reaches its full term, it may be extended by mutual consent of the Lender(s) and BLCT, at the end of each month by another month, unless the lender(s) asks us not to do so.
Change of Address and Personal Details	The lender(s) must notify BLCT of any change of address or other relevant personal details as soon as possible.
Demise or Incapacity	The lender(s) should ensure they make appropriate arrangements in the event of their demise or incapacity, such as a power of attorney and a will.
Non-Transferable	This Agreement is not transferable to any third party.
Modification of Agreement	No modification of this Agreement will be accepted, unless such is in writing and duly signed by all respective parties to this agreement.
Repayment of Qarz-e- Hasana	Repayment request must be made on the appropriate form and signed by the lender(s). Additionally, for payment to the lender(s) bank account a BACS payment request must be completed and signed by the lender(s). The repayment can only be requested by the lender, or both lenders when there is a joint account. The repayment can only be made to the lender's bank account or bank account authorised by both lenders when there is a joint account. Lender(s) to give 6 weeks prior notice for repayment of Qarz-e-Hasana of £5,000 and 8 weeks prior notice for repayment of Qarz-e-Hasana above £5,000 and work with BLCT in establishing mutually agreeable revised payment date and schedule. Upon the death of the lender repayment will only be made to another legitimate recipient when established through a legal authority.
Information Disclosure	Information about this Qarz-e-Hasana can only be given to the lender(s) or an authorised legal authority. To do so, the identity of the enquirer has to be established. If this could not be established, BLCT may write to the lender or his legal representative with the information requested.
Data Privacy	BLCT will process data in accordance with your rights under our Privacy Notice, a copy of which can be requested.
Changes to Conditions	Any changes to the above conditions may only be made with the agreement of all Trustees in office.
